PRIVACY NOTICE

PURPOSES AND METHODS OF PROCESSING PERSONAL DATA

The personal data provided by the Data Subject to Canossa Events Srl, registered in Reggio Emilia, Italy, with VAT ID 02431580352 ("Company"), including any images ("Data"), will be processed for the following purposes:

- a) to enable the Data Subject to participate in the Event Tribute 115° A.C Milano and use the relative services ("Service").

The processing of the Data for each of the aforementioned purposes can be carried out using paper-based, automated or electronic means, in particular via ordinary mail or by email, via telephone (e.g. automated calls, SMS and MMS messages), via fax and any other IT channel (e.g. websites, mobile apps etc.).

CONSEQUENCES OF THE FAILURE TO PROVIDE DATA

The provision of personal data is voluntary. However, failure to provide the Data marked as mandatory will render it impossible for the company to provide the Service. Failure to provide any other data not marked as mandatory will enable the service to be provided.

OTHER PARTIES WHO MAY PROCESS THE DATA

With the consent of the Data Subject, the image of the same can be published on social media channels and the company's communication materials.

The data may be processed by parties operating on behalf of the company in line with specific contractual obligations, in EU member states or in countries outside of the EU.

The data may be disclosed to third parties in order to comply with legal obligations or orders from public authority bodies, or to allow the Company to exercise its rights in court.

TRANSFER OF DATA OUTSIDE THE EUROPEAN ECONOMIC AREA (EEA)

Within the context of the company's contractual relations, the Data may be transferred outside the European Economic Area (EEA). This may also occur via the insertion of the data into databases managed by third-party companies operating on behalf of the Company. Management of the databases and processing of the Data therein must comply with the purposes for which the Data was collected, and such activities must be carried out in strict compliance with the applicable laws on the protection of personal data.

STORAGE OF PERSONAL DATA

The Data processed in order to provide the Service will be kept by the company for the period necessary to accomplish the Service and according to the rules and laws applying.

Furthermore, the Data processed in order to provide the Service may be stored for a longer period, to enable any disputes relating to the provision of the Service to be handled.

THE RIGHTS OF THE DATA SUBJECT

The data subject shall have the following rights:

1. the right of access, i.e. the right to obtain confirmation from the Company as to whether or not Data concerning him or her are being processed, and where this is the case, to obtain access thereto;
2. the right to rectification and erasure, i.e. the right to have inaccurate Data rectified and/or to have incomplete Data completed, and the right to have Data erased for legitimate reasons;
3. the right to impose restrictions on the processing of personal data, i.e. the right to request the suspension of data processing for legitimate reasons;
4. the right to data portability, i.e. the right to receive the Data in a structured, commonly-used and easily readable format, as well as the right to transmit the Data to another data controller;
5. the right to object, i.e. the right to oppose the processing of Data where legitimate reasons for this exist, including Data processed for marketing and profiling purposes, if this is envisaged;
6. the right to contact the competent data protection authority in the event of unlawful processing of the Data.

The Data Subject may exercise the rights listed above by writing to the data protection officer as mentioned above.
